(Art.19 – CRPD «...have the opportunity to choose their place of residence and where and with whom they live on an equal basis with others...»)

We started from:

- «Institutional» loneliness of families
- Lack of tailored services and support
- No possibility of choice
- Hospitalizations and institutionalization
- No decisions shared with families

SOLUTION:

- Everyone has the right to have a family
- Empowerment and active participation
- Social awareness and awareness of their role
- Train with institutions and service operators



"The Model Sardinia": action and outcomes of best practice of "social plural welfare"

Interventions based personalised plan

Needs assessment

- Health Analysis (health report)
- Family Situation Analysis (social report)

Setting Up Plan

 Track of the project, identifying intervention, goals, results and business plan in order to make it happen

Interventions:

- Education service
- Personal support and/or home care
- Reception at authorized day centers, limited to the payment of the social quota
- Stay for no more 30 days a year in authorised facilities
- Sports and socialisation activities

.....and now? A national law on the Life project: keyword


- Individual, personalized and participatory life project

Living the way I want! As?

We build together:

The *multidisciplinary evaluation* builds the individual project plans and designs, or rather coplans this perspective: the **focus is always on the person** in their **life context** (removing barriers, providing/organising facilitators) – it goes beyon the concept of pathology or, worse, category/disability Guarantee everyone the right to independent living and to choose where and with whom to live (Art. 19 - UN Convention)


